

## 2008 AMERICAN CANYON PATRIOTS FOOTBALL & CHEER PARTICIPANT INFORMATION

### CHECKLIST

- Submittal of signed Registration Form below.
- Submittal of Signed Parent's Code of Conduct.
- A player's certified birth certificate. (This will be returned to you in September, after certification.)
- A copy of your current medical card.
- A DVYFC physical certification card signed by a licensed physician.

**Note:** *This card will be mailed to you after receipt of your documentation and payment. You will also be able to pick it up in person at any of the sign-up dates.*

- A copy of the player's last report card for the 2007-2008 school year. We will collect these at Patriots Day.
- Registration Fee for Football \$215.00 or Cheer \$150.00
- Mandatory Fundraising Fee \$25.00/per participant

**Note:** *Registration Fee and Mandatory Fundraising Fee can be paid together.*

- Refundable Uniform/Equipment Deposit per child \$250.00  
*Uniform/Equipment Deposit checks will not be cashed and will be returned at the end of the season if all uniforms and equipment is returned in full. **Please date check October 31, 2008.***

- Refundable Parent Participation Deposit \$150.00  
*This check will not be cashed as long as each family fulfills an obligation of 4 hours per season. There are many opportunities in which to fulfill the obligation. Choose the one that works best for you. Sign up early! Once your family obligation has been met, you will receive your parent participation deposit check back. **Please date check October 31, 2008.***

#### **There are three ways you can register and pay:**

- **IN PERSON:** Come to one of the Sign-up dates (see our website for dates). Forms are available online and also at the Sign-up location.
- **BY MAIL:** Fill out all the required forms and submit all with required documents along with a money order or cashier's check with all required forms and documents to our office at: 101 W. American Canyon Road, Suite 508 #173, American Canyon, Ca. 94503
- **PAY ONLINE:** Pay registration online ([www.acpatriots.com](http://www.acpatriots.com)) then mail in all forms and required documentation to our office at: 101 W. You can also pay online then bring all your documentation along with a copy of your registration payment receipt to one of the Sign-up dates.





## AC Patriots Pop Warner Football & Cheer Parent Code of Conduct Agreement 2008

The rules listed below are designed to allow a safe, positive environment for **all children to participate, learn, and have fun.**

1. I agree to make sure that my child/children are on time to all practices, games and events.
2. I agree to pick up my child on time after all practices, games, and events. In the event I am late, I agree to pay a late fee imposed of \$1 per minute, for every minute I am late. Any late fee imposed will be due and payable at the next practice, game, or event, whichever comes first. Failure to pay this fee will result in my child being unable to participate in practice until this financial obligation is fulfilled.
3. I agree to stay in the designated Parent/Spectator area. I will not enter the field. Should my child need attention while he/she is on the field, I will allow the coach, board member, and/or Emergency Medical Personnel to assist on the field.
4. I agree that I will not "coach" my child from the sideline. I understand that when I am yelling instructions to my child neither they nor the other players can hear the coaches. I also agree that I will not follow the game up and down the sidelines as that makes it difficult for other spectators to view the game.
5. I agree to cheer for my child, other children (and even the other team) when appropriate.
6. I agree I will not use profanity, obscene gestures or any type of harassing behavior, verbal or non-verbal, against anyone on the field. This includes coaches, referees, chain-gang, board members, players, opposing team supporters, etc.
7. I agree that I will conduct myself in an appropriate manner at all times. I understand that it is very important to set an example of good sportsmanship for the children involved in American Canyon Patriots and the community.
8. I agree that I will set an appropriate time away from the game to ask any questions I may have of the coach (es). I will not have a meeting with him directly before, during or immediately after a game or practice.
9. I agree to respect the time, effort, and hard work of all the volunteers who staff the American Canyon Patriots. I understand that it is 100% staffed by volunteers who make it possible for my child to participate in the sport. I also understand and agree not to contact any Patriot member at their place of business to conduct AC Patriot business. I will contact them either at the field, through the website or leave a message on the hotline requesting a meeting or call back.
10. I agree to abide by any direction given to me by an AC Patriots coach, board member, or other official of Pop Warner.
11. I agree to participate in all AC Patriots Fundraiser Events.
12. I agree that there will be a responsible adult, either myself or another adult I designate, present at all of my child(ren)s games.
13. I understand that pictures of my child may appear on the AC Patriots website, in the newspaper or other venues.
14. I understand that my child will be placed on the most appropriate team level for his/her age, weight, and experience.

By signing this, you agree to abide by the rules of conduct outlined in this form. Violations on the field during game day, practices or any other AC Patriots event may result in your being expelled from the event. Further violations may result in being banned from all American Canyon Patriots events.
