PARENT CODE OF CONDUCT AGREEMENT 2010

The rules listed below are designed to allow a safe and positive environment for all children to participate, learn and have fun.

1. I agree to make sure that my child/children are on time to all practices, games, and events.
2. I agree to pick up my child on time after all practices, games, and events. In the event I am late, I agree to pay a late fee imposed of \$1 per minute, for every minute I am late. Any late fee imposed will be due and payable at the next practice, game, or event, whichever comes first. Failure to pay this fee will result in my child being unable to participate in practice until this financial obligation is fulfilled.
3. I agree to stay in the designated Parent/Spectator area. I will not enter the field. Should my child need attention while he/she is on the field, I will allow the coach, board member, and/or Emergency Medical Personnel to assist on the field.
4. I agree that I will not "coach" my child from the sideline. I understand that when I am yelling instructions to my child neither they nor the other players can hear the coaches. I also agree that I will not follow the game up and down the sidelines as that makes it difficult for other spectators to view the game.
5. I agree to cheer for my child, other children (and even the other team) when appropriate.
6. I agree I will not use profanity, obscene gestures, or any type of harassing behavior, verbal or non-verbal, against anyone on the field. This includes coaches, referees, chain-gang, board members, players, opposing team supporters, etc.
7. I agree that I will conduct myself in an appropriate manner at all times. I understand that it is very important to set an example of good sportsmanship for the children involved in American Canyon Patriots and the community.
8. I agree that I will set an appropriate time away from the game to ask any questions I may have of the coach (es). I will not have a meeting with him/her directly before, during or immediately after a game.
9. I agree to respect the time, effort, and hard work of all the volunteers who staff the American Canyon Patriots. I understand that it is 100% staffed by volunteers who make it possible for my child to participate in the sport. I also understand and agree not to contact any Patriot member at their place of business to conduct AC Patriot business. I will contact them either at the field, through the website or leave a message on the hotline requesting a meeting or call back.
10. I agree to abide by any direction given to me by an AC Patriots coach, board member, or any other official of DVYFC.
11. I agree that there will be a responsible adult, either myself or another adult I designate, present at all of my child (ren)s games.
12. I understand that my child will be placed on the most appropriate team level for his/her age, weight, and experience.
13. I understand that the Participant roster placement will be at the sole discretion of the A.C. Patriots Football and Cheer Association, Athletic/Cheer Directors and their staff.
14. **Player Dress Code (Football only):** I understand that each player is required to wear khaki pants and a white polo shirt for their pre-game arrival at home and away games. The Patriots will make arrangement for procurements for the polo shirts with an embroidered Patriots logo and make them available at a discounted price. Once purchased, these shirts will be mines to keep. Parents will be responsible for the purchase of the khaki pants.

By signing this, you agree to abide by the rules of conduct outlined in this form. Violations on the field during game day, practices or any other AC Patriots event may result in your being expelled from the event. Further violations may result in being banned from all American Canyon Patriots events.
